The joint sickness insurance scheme (JSIS) has established agreements with hospitals and other health providers in order to regulate the maximum fees charged by doctors, surgeons and in some establishments, room prices. See the list by countries below.

Other agreements are established with some centres for the <u>health screening programmes</u>.

They do not modify the procedures to be followed (prior authorisation, letter of <u>direct billing</u> in case of hospitalisation) nor the conditions or rate of reimbursement laid down in the Rules. Therefore they do not always guarantee a reimbursement of 80 or 85%. You have the free choice of hospital or clinic and practitioner.

For hospital services provided within hospitals, the rates have been fixed, hospital by hospital, by the Luxembourg government and the National Health Fund. For 2024, the rates can be found on this link \triangle .

Several items may be invoiced simultaneously depending on the nature of the hospitalization.

The attention of members is drawn to the fact that for certain outpatient/minor services, community medicine could be less expensive than hospital medicine.

In your interest, it is essential that you apply for prior authorization for Rehazenter.

Hospital rates do not include doctor's fees. Doctor's fees are also set by the Luxembourg authorities. To find the rates, please consult the NHF (CNS) nomenclature by entering the code appearing on the statements of fees with regard to the services invoiced by the doctor. The NHF (CNS) nomenclature is available at the following link: <u>Invoices explained - Tools / Calculators - CNS - Luxembourg (public.lu)</u>

It is important to be aware that the amount that will remain at your expenses may be high. For this reason, it is useful – even when it is not mandatory – to know the rates charged **before** the planned expense. JSIS advises you to request a cost estimate from both the hospital and the doctor prior to any hospital service, which will allow you to assess the amount that will remain at your expenses.

If you have any questions about your hospital bills/physician fees, please contact the billing department of the hospital/doctor's office. If you receive an invoice that does not appear to comply with the above rates, please contact JSIS via Staff Contact so that we can assist you.
