


ADD eID TO YOUR EU LOGIN ACCOUNT AFTER 1 JULY 2025

If you already created an EU Login account earlier, but did not activate an alternative log in method before 1 July when the SMS method was phased out, follow this guide to regain access to your account, logging in using your national eID:

1. Launch <https://webgate.ec.europa.eu/cas/>. If you see the screen below (not always shown), enter the email address used to create your EU Login account:

2. You will now see the screen below. First enter your **EU Login password**. Update it if required (*if you forgot your EU Login password, click on [Lost your password?](#) to reset it. It must contain **at least 10 characters**, including lower and upper case letters, numbers and special characters (-, ?, &, % ...). **Tip:** start it with the current **year and month**, followed by your preferred (permanent) password, such as **25-08Ukraine** (if created in August 2025).*

Next, check that your **verification method** is set at **"Password"**. If required, click on the arrow in the black box to find it in the drop-down menu. Click on it and then click **"Sign in"**.

3. On the next screen, click on the cog wheel next to your name top right and select **"My account"** from the drop-down menu:

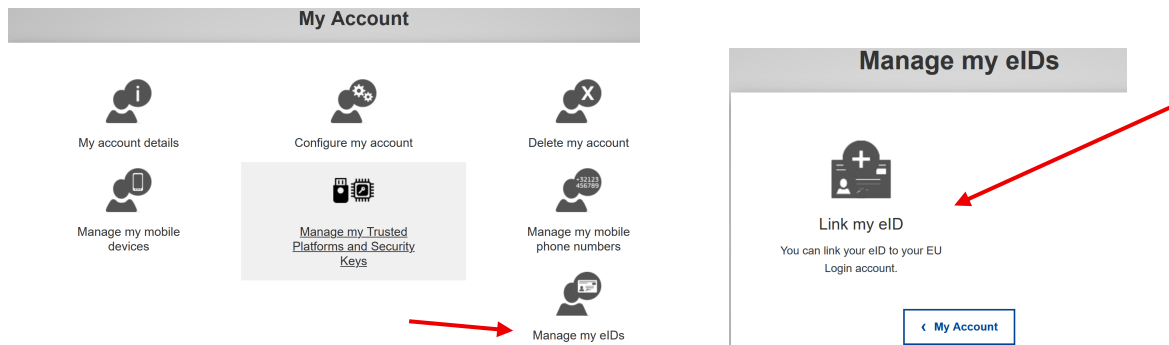

4. Select **"Manage my eID"** which enables you to log in using your national electronic ID. On the next screen, click on **"Link my eID"**.



5. You will now see a screen with a lot of flags. If your country is listed, select that and then click **Submit**.

Now authenticate as you usually do with your national eID.

At the end of the procedure, the EU institutions will ask you to confirm your personal data. Confirm, and you will then receive a message that your eID was successfully linked to your EU Login account.

Now log out.

You have now regained access to your EU Login account. When logging in, remember always to check that the verification method is set at Electronic ID as shown below. If required, click on the arrow in the black box to select the correct verification method.

Next, follow each time the procedure in point 5, and you are in!
